The vessels included in this agreement are: "Princess Ingrid Alexandra""Johan Hjord""G.O. Sars""Hydrograf""Dr. Fridtjof Nansen" (see note 1) Other vessels (see note 2) General workshop services will not include major assignments such as the expected mid-life upgrade for G.O. Sars. The contract is also subject to assignments exceeding NOK 25 million in points 3.6 and 12.3. Note 1 "Dr. Fridtjof Nansen" will normally operate outside Of Europe. The classification and maintenance work will therefore typically take place in Africa or Asia. The vessel will, therefore, not normally use this contract, but if the owner or operator decides to move the vessel to Norway for operation or circulation here, it is subject to the vessel also being able to use this contract. The estimated scope under the agreement includes a restricted call-off on general workshop services for "Dr. Fridtjof Nansen". Note 2 Other

Kirjeldus: A short distance between the vessels' home port and the tenderer's location reduces the climate and environmental impact of the procurement. Under this award criteria, the tenderer's proximity to the vessels' home port; Bergen, be evaluated. This is due, among other things, to the following conditions; After completing the research mission and before a vessel is going on a workshop stay, the vessel must call at the home port of Bergen for the unloading of scientific samples, research equipment, containers, frozen fish etc. The primary activity for the Contracting Authority is to carry out research missions and develop the scientific basis for sustainable management of the resources and the environment in the marine ecosystems. With tight schedules (frameworks) for carrying out expeditions, and with a view to maximising the number of expeditions on the vessels, a workshop close to the home port of Bergen will be considered advantageous not only by climate also for logistical reasons. Documentation requirement: When evaluating this award criteria, the workshop's geographical location as regards proximity to the vessels' home port will be awarded. The distance is measured by using the nautical distance table. Tenderers must comment on their location under this award criteria or enclosed it with the tender documents in Merccell.
