Tenders cannot, therefore, be changed after the tender deadline has expired. Furthermore, attention is agreed that tenders that include significant deviations from the procurement documents shall be rejected in accordance with the Public Procurement Regulations § 24-8(1) b. The contracting authority can reject tenders that include deviations from the procurement documents, uncertainties etc., which must not be considered insignificant, cf. The regulations § 24-8(2) a. The tenderer is strongly encouraged to follow the instructions given in the procurement documents and to possibly ask questions about uncertainties to a gender neutral preferred via Mercell.

It is the tenderer's responsibility to document relevance through the description. The tenderer shall use Annex 2 as the template.
