Procurement/call-offs will take place by each individual organisation/unit in the municipalities making orders in accordance with the contract. The estimated value for the contract period (including the option years) is approx. NOK 5-6.2 million (excluding VAT). The contracting authority draws attention to the fact that the estimated volume and value is based on historical procurements and future budgets. and is not binding for the contracting authority, but it shall only be seen as a guideline. The volume can vary and will depend on, among other things, the contracting

authority's needs, activities, budgetary situation, political decisions and other framework factors.
