Tenderers who, according to the contracting authority's overall and factual assessment, show significant weaknesses in the economy can be rejected. Conditions that, among other things, may cause doubt about the tenderer's financial carrying capacity are

negative equity, residual deficits, payment remarks, weak liquidity, ongoing insolvency or debt negotiations, low credit worthiness or other conditions that collectively indicate increased financial risk.
