The aim of the procurement is to establish a new fill-free artificial grass system suitable for football activities in Nordic conditions. The system shall contribute to high durability, stable playing properties and an appropriate operational and maintenance need throughout the year. The procurement shall also support the municipality's goal of environment, sustainability and long-term resource management. The choice of a fill-in free artificial grass cover is justified in assessments connected to operation, maintenance and environmental impact. Tenderers must therefore assume that a complete system is requested that safeguards these considerations within the framework of the tender documentation.
