The aim of the procurement is to enter into cooperation with one (1) tenderer who can assist with the development of managers, teams and organisation that shall support AtB's ability for strategic management, change and implementation. The contract will be regulated by SSA-R with annexes. The contracting authority will make call-offs with SSA-B. The contract is valid from when the contract is signed and it has a duration of four years. The contracting authority has a unilateral option for 1 year + 1 year + 1 year + 1 year. The maximum contract length is 8 years. The estimated value of the framework agreement is NOK 1 million per annum. At the maximum contract length, the estimated value is NOK 8 million. The maximum total value of the framework agreement is NOK 12 million due to the expected price growth in the period as well as unforeseen events that may require more frequent use of the service.
