Kirjeldus: The Norwegian Public Roads Administration Operations and Maintenance invites tenderers to a competition for the following contract work: Framework agreement for tunnel and rock protection for Trøndelag, Møre og Romsdal. The contract includes cleaning and bolting protection, establishing of new and improving existing water and frost protection in tunnels, clearing and bolt protection in cuttings, establishing different types of meshes (ice nets, erosion network etc.), improvements and establishment of new security measures in the open air on European and national roads. in Trøndelag, Møre og Romsdal. The measures will vary in extent. Outside of general processes, a couple of concrete projects are described to be carried out: TR01: E6 Kvam – clearing and work protection cutting. Modification of the existing network TR02: E6 Cleansed - clearing and work securing cutting. Assembly of an ice network. TR03: E39 Søvassdalen - clearing and work securing cutting. Assembly of an ice network. MR01:E39 Brusdalen – clearing and work securing cutting. MR03: E136 Sørnes tunnel – Rensk and securing, establishment of a new water-frost protection vault. Consideration shall be given to set timetables for public transport. Routines must be established. for emergency emergency services. All traffic deviations/driving vehicles in tunnels shall be carried out for work. passing must be clarified by the traffic conductor with work teams in the tunnel before emergency services are released. through. There will be a lot of focus on the contract work notification as the work is ongoing on the existing road network. The location of the traffic conductor shall always be risk assessed in the contractor's work warning plan. The contracting authority would like parallel framework agreements with up to 3 contractors per area, based on which tender is best in accordance with the award criteria.

Valikukriteeriumi kirjeldus: Tax certificates Tenderers shall, upon request by the contracting authority, submit a tax certificate for VAT and tax certificates issued by a competent body in the tenderer's home country or the country where the tenderer is established. The certificate shall document whether the tenderer has fulfilled his obligations to pay taxes, duties and social security contributions. The certificate must not be older than 6 months calculated from the deadline for submitting a request for participation in the competition or a tender.

If a tenderer has a justifiable reason for not submitting the documentation that the contracting authority has required, he can document his economic and financial capacity by presenting any other document of relevance to the company's fiscal figures/economy. Tenderers shall justify why they cannot submit the documentation required by the contracting authority.

The overview shall, cf. the form "Response Document for assessment of the tenderer's technical and professional qualifications - Operation and maintenance" (See "General contract documents the Norwegian Public Roads Administration, Various documents), including, among other things, the following for each of the contracts: •

Name of the recipient (contracting authority). • Contact person/reference person at the contracting authority with contact data (telephone number and email address) and a statement of the person's role at the contracting authority during the contract. • Date of the delivery. • The contract's value. • What work was carried out by the tenderer, including as the main contractor or sub-contractor, and what work was carried out by sub-contractors. • A description of what the contractual works were about, including relevance to the qualification requirement.

The tenderer can, if necessary, rely on other companies' capacity to fulfil the requirements for economic and financial capacity and/or the requirements for technical and professional qualifications. Documentation requirement Tenderers shall confirm that they fulfil this requirement when submitting their tender. In addition, each individual entity that the tenderer will use to submit a separate ESPD form when submitting a tender. Tenderers shall, upon request from the contracting authority, present the following documentation proof: • Documentation that shows that the tenderer can use the necessary resources for the entities that they will use, for example, a commitment statement from these businesses. The template for the commitment statement is published on: <https://www.vegvesen.no/fag/veg-og-gate/konkurranse-og-kontraktsdokumenter/generelle-kontraktsdokumenter/>. • Documentation that shows that the company(s), that the tenderer will use, fulfil the qualification requirement 'the tenderer's organisational and legal position'. • Documentation that shows that the company(s), that the tenderer will use, fulfil the relevant qualification requirements. • If a tenderer will use the capacity of other companies to fulfil the requirements for economic and financial capacity, a signed joint and several liability statement must be enclosed. The template for a joint and several liability statement is published on: <https://www.vegvesen.no/fag/veg-og-gate/konkurranse-og-kontraktsdokumenter/generelle-kontraktsdokumenter/>. If a tenderer will use the capacity of other companies to fulfil the requirements of relevant experience, these entities shall carry out the services or the building and construction work that requires such qualifications.

Valikukriteeriumi kirjeldus: Suppliers who participate in a working partnership Several tenderers can participate in the competition jointly. The community must see to the necessary documentation that all the qualification requirements are met. The contracting authority will assess each individual supplier in the community against the provisions on rejection, cf. § 9-5 and § 24-2, this except the provision in § 9-5 (1) letter a) and § 24-2 (1) letter a) fulfilment of the qualification requirements, which will be applied to the jointly combined set. Tenderers who participate as a working partnership will be assessed collectively for the qualification requirements, with the exception of the requirements for the tenderer's organisational and legal position, documentation for absence of rejection reasons, tax certificates and authority for information on tax and duties (OSA). Documentation requirement Tenderers shall confirm that they fulfil this requirement when submitting their tender. In addition, each individual entity

in the (work) group shall submit separate ESPD forms when submitting a tender. Tenderers shall, upon request from the contracting authority, present the following documentation proof: • An account of the group (including each participant's role), each participant's organisation number, address and nationality. • The same documentation as individual tenderers shall be provided for each individual tenderer who participate in the group. • Declaration of joint and several liability to the contracting authority. The template for a joint and several liability statement is published on: <https://www.vegvesen.no/fag/veg-og-gate/konkurranse-og-kontraktsdokumenter/generelle-kontraktsdokumenter/>. The community of suppliers can, if necessary, rely on other entities to fulfil the qualification requirements, see the point on support from other companies to fulfil the qualification requirements. The contracting authority requires that the tenderer who fulfils the requirements for relevant experience shall carry out the services or the building and construction work that requires such qualifications.

Kriteerium: Registreerimine asjakohases kutsealases registris

Valikukriteeriumi kirjeldus: Particularly on newly established tenderers A tenderer who is newly established and cannot present all the required documentation must be particularly careful to document and substantiate that they still have the prerequisites required to fulfil the contract. It is particularly important that such tenderers can document a sufficiently large workforce for the execution of the contract, including technical and professional qualifications. Newly established tenderers emphasise that it is the tenderer's ability as such to carry out the contract that is assessed, not individual persons' competence in isolation. If a newly established tenderer has experience from contracts, the most relevant contracts from which the tenderer has experience must be completed in accordance with the documentation requirements regarding relevant experience. This is even if the contracts are of such a nature that they do not fulfil the specified requirements. Missing or inadequate documentation in one or more of the requirements can result in the tenderer being rejected. Insufficient or incorrect completed response form can also lead to rejection. Tenderers who have established themselves within a new discipline can also be seen as newly established.

Liik: Kvaliteet

Nimi: Justification for the use of climate and environmental requirements in the requirement specifications.

Kirjeldus: Climate and environment has not been used as the award criterion in this procurement. In accordance with the Public Procurement Regulations (FOA) § 7-9 fourth paragraph, award criteria can be replaced with requirements if this gives a clearly better climate and environmental effect. It has been considered for this procurement that climate and environmental considerations are taken care of through concrete minimum requirements in the tender documentation and contract. The procurement is for a framework agreement where the work is ordered through call-offs. The extent, location and character of the individual works will vary and are to a limited degree known at the time of publication. This means that tenderers will, to a small degree, have sufficient basis for preparing and competing on relevant climate and environmental measures in the tender phase. The climate and environment as the award

criterion is therefore assessed to have a limited effect. The largest climate and environmental impacts in the contract are related to transport of personnel, emissions from machines and vehicles, rock protection work as well as waste management. The transport of personnel with light vehicles in particular makes up a significant part of the climate footprint. In order to ensure real climate and environmental effect, there are therefore concrete requirements in the contract, including:

- The requirement that the shotcrete shall have a maximum documented GWP-total value (A1-A3) that is not higher than 280 kg CO₂-ekv. /m³ for concrete specified in class M45 and 300 kg CO₂-ekv/m³ for concrete, specified in classification M40.
- Concrete and concrete elements are required to be cast on site as a minimum to have low carbon class 20 (NB37).
- A maximum emission factor of 1.4 kgCO₂e/kg will be required for rock bolts.
- Maximum emission factor of 2 kgCO₂e/kg will be required for the rock protection network.
- EPD shall be delivered and reports with added amounts for all input factors included in the contract work. Contract specific EPDs shall be provided for products covered by the minimum requirements.
- Requirement that 100% of light vehicles shall be carried out with zero emission vehicles or biogas.
- Requirement for an environmental management system (ISO 14001 or equivalent)
- Requirements regarding emission standards for vehicles and machines (minimum Euro 6 and Step 4).
- Requirement for contingency for handling pollution, including available absorption agent.
- Requirement for covering asphalt at risk of fallout to prevent replacement

· During mini-competitions, the builder can set stricter environment and climate requirements than what applies to the contract and processes today. There will be separate processes on this in a mini competition where relevant. A major focus here will be the transition to electricity or biogas for call-offs where suitable.

· Contractor shall at all times strive for further improvement influences on greenhouse gas emissions where this does not have a significant negative effect on price, progress and quality. Possibilities for this shall be lifted for the builder.

· Materials/matter shall as far as possible be reused in the project in cases where suitable.
