The scope of this contract will require the successful service provider to cater for all waste and recycling streams at these sites except the following: • Glass and Aluminum cans, • All electrical goods, household batteries, electric fence batteries and accumulators which are catered for under the WEEE recycling scheme • Textiles and Newspapers • Green Waste.
