Menetluskorra kirjeldus: The contracting authority shall enter into new contracts for winter maintenance of municipal roads and open spaces for the 2026/2027 - 2028/2029 seasons, with a unilateral option for a further 1 year + 1 year. The duration of the agreements can, therefore, be a total of five years. The procurement concerns: Roads (deals with areas including pavements, foot and cycle paths, junctions, bus shelters/bays, turning places etc.) Municipal spaces (parking places etc.) Sub-contracts shall be signed in accordance with the route overview chapter 1.4/annex 1. Tenderers can submit tender offers on one or more sub-contracts. The maximum number of sub-contracts that can be awarded to a tenderer is 12. The tenders, per sub-contract, shall be independent of each other.
