This is distributed between the sub areas in the following way: The estimated value for sub-area 1 amounts to NOK 10,500,000 excluding VAT, and the maximum amount is NOK 12,900,000 excluding VAT. The estimate is made based on historical figures and/or expected future use according to the contracting authority's best judgement.
