In order to meet the needs of the future in a satisfactory manner, the contracting authority shall enter into a dynamic procurement scheme for safeguarding competition for vehicles under 7.5t. This applies to the procurement and leasing of vehicles for i.a. the sectors home nursing, property, engineering, school, institution and nursery school.
