The annual daily traffic is approx. 45,000. The tunnel shall be upgraded in accordance with the tunnel safety regulations and equipment in and outside the tunnel shall be replaced and replaced with new equipment that meets the current requirements. This includes, among other things: • New ventilation system. • New lighting installations with both new lights in the tunnel roof and continuous evacuation lights. • Extinguishing water shall be set up for the fire brigade. New system for handling emissions and tunnel washing water that fulfils emission requirements. • New signage with barriers, lane signal and variable signs. • Emergency stations with fire extinguishers and telephones. • Camera with coverage throughout the entire tunnel, which gives an alarm during events. • New technical building in the tunnel in the existing mountain room. • A new stop section shall be established at the technical building. • Demolition of existing air treatment plant.

If the contractor has a justifiable reason for not submitting the documentation that the builder has demanded, he can document his economic and financial capacity by presenting any other document of relevance to the company's fiscal figures/economy and which the builder deems suitable. The contractor shall justify why he cannot present the documentation the builder has demanded.
