The company score between 71 and 100 gives an international score of A. The company score between 51 and 70 gives an international score of B. Company score from 45 and 50 equals one C in the upper "layer". Recently established companies, some foreign companies or companies without any reporting obligation to the Brønnøysund Register Centre will not always have a credit rating as documentation that the qualification requirement is fulfilled. In such cases, the requirement can be compensated with alternative documentation. In these cases the Contracting Authority will request alternative documentation. If the tenderer does not meet the requirements set for sufficient economic and financial capacity, the tenderer will be rejected.
