The contracting authority reserves the right to request supplementary documentation if necessary to assess the tenderer's economic and financial capacity. Tenderers who do not alone fulfil the requirement for economic and financial capacity and who rely on other companies' financial capacity to

fulfil the qualification requirement, shall submit a completed and signed Annex 6 - Commitment Statement. Tenderers who, according to the contracting authority's overall and factual assessment, show significant weaknesses in the economy can be rejected. Conditions that, among other things, may cause doubt about the tenderer's financial carrying capacity are negative equity, residual deficits, payment remarks, weak liquidity, ongoing insolvency or debt negotiations, low credit worthiness or other conditions that collectively indicate increased financial risk.
