It is necessary to procure office furniture such as panel furniture, office chairs, environment furniture and interior, including textiles and interior such as curtains, carpets, sound absorbers etc. and for facilitating functioning office work stations for all employees as well as supplementing the new government quarter. In addition furniture and interior shall also be procured for the Government's representation facility (including the Prime Minister's residence), commuter residences and foreign stations thereof. The list is not exhaustive. The procurement shall also include additional services such as interior architect services, repairs and maintenance, upgrading and drawing of existing furniture, as well as further mediation of existing furniture holding for reuse and securing optimum material recovery.
