Other documentation of equivalent quality assurance measures will be accepted on the terms in the procurement regulations § 16-7 third paragraph.

The description shall state: * the contracting authority, * contract period, * the assignment's nature and extent, * stand-by and response time requirements, * the tenderer's role and responsibility, and * name and contact information of a reference person at the contracting authority. The contracting authority reserves the right to contact the provided references in order to verify the information.
