Tenders can be submitted for one or more locations that fulfil the requirements in the tender documentation. Each offered 24 hour resting place will be assessed as an independent tender. The contracting authority shall have a maximum of 24 hour resting place per municipality. A maximum of one contract will therefore be awarded for 24 hour resting places per municipality. The contracting authority can award contracts to one or more tenderers. The tenders will be evaluated and ranked in accordance with the competition's award criteria. The contract will be awarded to the tenders that together give the best relationship between price and quality and that best cover the contracting authority's need for placement places on the stretch.
