Within the municipality, there are several records of vulnerable and valuable habitat types, including coastal heathlands, semi-natural grasslands, grazing and hay meadows, rainforests, and brackish-water deltas. Gjesdal municipality primarily needs assistance for projects that receive "Naturesats" funding through the Norwegian Environment Agency's grant scheme.
