The National Offender Management Service is an executive agency of the Ministry of Justice responsible for the administration of prison and probation services within England and Wales and will be replaced by Her Majesty's Prison and Probation Service as of the 1.4.2017. In issuing this Prior Information Notice, the Ministry of Justice is seeking to inform the market of this planned procurement with a view to initiating a series of market consultations in the near future.
