Zone 1 covers Bideford/Northam, Great Torrington and Holsworthy.

Zone 2 covers Ilfracombe, Lynton/Lynmouth, Barnstaple, South Molton.

Zone 3 covers Tiverton, Crediton, Cullompton.

NDHT is now looking for additional Tier 2 providers to join our Framework Agreement to ensure we have sufficient capacity across Northern and Mid Devon.
