The delivery includes statutory inspections, control and service of technical installations that require regular follow-up, including assignments that require special certification or special competence. If the tenderer does not have such internal competence, it shall be collected externally and invoiced at the contract's ordinary hourly rates without mark-up or extra costs for the contracting authority. Tenderers shall act as a proactive consultant and actively choose environmentally friendly materials and energy efficient systems with a long lifetime to ensure good operational security and a low environmental impact. The agreement shall take care of both planned assignments and acute needs, with requirements for a quick response time.
