In addition a preliminary project for a new bridge in Busdalen (Sjusetevegen bridge) shall be required, which shall clear and cost estimate the detailed engineering design services and execution. It is also set up to start with a condition assessment of existing flaum protection along the river to the sea. The procurement's value is estimated to: NOK 2,500,000 excluding VAT. The volume is an estimate and is not binding for the contracting authority. See the procurement documents for further information. This procurement is considered to have an immaterial impact on climate and the environment, cf. the Public Procurement Act § 5b third paragraph.
