Two types of equipment shall be procured for the purpose of preventing unwanted monitoring and monitoring. The contracting authority considers it appropriate to divide the procurement into two sub-contracts, as not all tenderers cover both areas. The contract includes: • Lot 1: Equipment to prevent audio recordings by blocking or interfering with microphone functionality. • Sub-contract 2: Equipment for screening or screening electronic signals that shall prevent tracking and electronic communication. The box should prevent embedded Microphones can make meaningful sound recordings, for example, by generating disturbing sound or noise that makes recording even if the device is compromised. The equipment shall be robust, user friendly and suitable for repeated use in the Contracting Authority's ordinary working day. The contract shall also include the accompanying services for sub-contract 1 that are necessary for safe and stable use of the equipment throughout the entire contract period. This includes service, maintenance, repairs and any replacement of equipment, so that the functionality and security level are maintained over time. The maximum roof is set at NOK 5 million.
