The scope of work shall include designing, fabricating, and delivery of Electric Auxiliary Boilers that meets specifications, drawings, and other purchase order requirements. Delivery may be performed by either Bechtel or company, as determined by Bechtel. Technical Capability b. Previous Proven Relevant Experience c. Quality d. Delivery Management Team e. Schedule The evaluation factors to determine the selected proposal shall be based on the commercial factors that impact overall cost, such as freight, proximity to project site, Carbon Border Adjustment Mechanism (CBAM) requirements, payment terms, performance and payment securities, and insurance.
