Principales caractéristiques de la procédure et informations sur l'endroit où obtenir les règles complètes applicables à la procédure: The procurement's consumption is estimated to approx. 40 million kWh over a four year period. The estimated amount is calculated including options (the maximum contract period is four years, 2+1+1). The estimated consumption is not binding for the contracting authority. The National Library estimates only one framework that is very uncertain due to variations in power prices. The estimate of kWh will then be the best estimate we take based on the start-up of the contract, it is estimated to be valid from 1 June 2026.
