Who shall meet the requirement: -Vendor - Companies that the tenderer will use through a commitment statement. -If several suppliers participate in the competition as a working partnership , the requirement applies for each participant in the community. How to

document fulfilment of the requirement: Tax and VAT certificate or equivalent documentation from the state where the company is established that shows that the tenderer has its tax and VAT payments in order. The certificate or equivalent documentation must not be older than 6 months calculated from the deadline for applying for qualification.

Who shall meet the requirement: -Vendor - Companies that the tenderer will use through a commitment statement. - If several suppliers participate in the competition as a working partnership, the requirement applies for each participant in the community. How to document fulfilment of the requirement: Company Registration Certificate or equivalent documentation that shows that the company is legally established and registered. Norwegian companies require registration in the Register of Business Enterprises. Foreign companies are required to have registration in an equivalent company or trade register in the country where the company is established.

Cur síos ar an gcritéar roghnúcháin: Tenderers who will use the capacity of other companies to fulfil the qualification requirements shall demonstrate this. If the tenderer relies on other companies to fulfil the requirements for economic and financial capacity, joint and several liability is required between the companies for fulfilment of the tenderer's obligations in accordance with the contract. If the tenderer supports themselves in other entities to fulfil the requirements for education and technical and professional qualifications or the requirements of relevant professional experience, these entities shall carry out the work or services that require such qualifications. Who shall meet the requirement: -Vendor - If several tenderers participate in the competition as a working partnership (working partnership), the requirement applies to the working partnership. - Companies that the tenderer will use through a commitment statement. How to document fulfilment of the requirement: The contracting authority's template shall be used for the delivery of a written and signed commitment statement from each committed company. The commitment declaration shall document that the tenderer has the right to use the necessary resources at the committed company. The tenderer shall, in the ESPD form, respond to whether they will use the capacity of other entities. The obliged companies shall submit a separate ESPD form. Tenderers shall also submit an organisation chart or other written documentation with an overview of all the committed companies. The documentation shall describe how the qualification requirements in total are fulfilled and how the committed companies will contribute to ensuring satisfactory execution of the contract.

The contracting authority's template for working partnerships shall be filled in and signed. Each participant in the group shall submit a separate ESPD form.

qualification requirements for finances. - If several tenderers participate in the competition as a working partnership (working partnership), the requirement applies for each participant in the working partnership. How to document fulfilment of the requirement: Credit rating, not older than 6 months prior to the deadline for applying for qualification. The credit rating shall be issued by a certified credit rating company, which has a licence to operate within the EU/EEA area. The tenderer can rely on a parent company to fulfil the requirement. If so, a declaration is required that the parent company is joint and severally responsible for the fulfilment of the tenderer's obligations in accordance with the contract.

A minimum of one of the reference projects shall include the use of a National Goods Model (NGM), and calculation of useful effects for goods traffic. Who shall meet the requirement: - The tenderer, or - Companies that the tenderer will use through a commitment statement to fulfil the qualification requirement. How to document fulfilment of the requirement: An overview of three assignments that the tenderer has carried out in the last three years. The overview shall contain a description of the assignments which include information on the assignments' value, date of execution and recipient (name, telephone number and e-mail address). It is the tenderer's responsibility to document relevance through the description. Tenderers can document their experience by referring to competence of the personnel he has at his disposal and can use this assignment, even if the experience has been worked up while the personnel have served another service provider. The contracting authority reserves the right to contact the references.

Competence and experience connected to socio-economic analyses carried out in accordance with the Norwegian Public Roads Administration's handbook V712 Impact analysis/priced consequences, by using a calculation tool EFFECT (with and without

connection to the transport model). CVs shall be submitted for three (3) key persons. The contracting authority's CV template shall be used. The contracting authority emphasises the importance that the number of CVs that are delivered is in accordance with the tender documentation.
