The contract also includes the establishment of a temporary roundabout in Skumsrudvegen, establishment of site roads, excavation on land, work on cultivated land such as laying of water and sewage pipelines, reinventing matter and separation of rock from masses, drilling under Skumsrudvegen, pipe sheet for water and sewage routes skumsrudvegen-VBA, reception and laying of PE pipes and pipe parts, refill works, adjustments etc. Hammer drilling shall be carried out for 3 DN813, 1 DN457 pipe pipe under Skumsrudvegen, and pulling in water and sewage pipelines for a pipe under Skumsrudvegen. In addition this contract includes the establishment of a rigging site and construction road within an area that is currently used for agriculture. Other work, including the sea facility and the actual water treatment facility, will be established through several separate contracts. The contracting authority with the pipe supplier delivers PE pipelines to the stated area of the rigging site. The rigging site will be chosen by the builder in accordance with the prepared drawings.
