contract. A letter of consent between the members of the group should be included in the

request to participate and all the information required under the contract notice should be

provided for each member of the group. In the case of a joint tender, all members of the group

assume joint and several liability towards the Contracting Party for the performance of the con-

tract as a whole, i.e. both financial and operational liability. The operators forming a group

must designate one of them as a single point of contact (SPOC) towards the Contracting Party for the administrative, financial and operational management of the contract.
