The speed limit in the tunnel is 80 km /h. It has approx. 6% falls in the direction of Bjørkheim. The tunnel was opened to traffic in 1976. The upgrading mainly includes replacing and modernising electrical and technical control installations, the establishment of a new technical building in the open air, a new drainage and surface water system, as well as new railings both in the tunnel and in the open air zone. The completed upgraded tunnel shall have a lane width of 3.10 metres and the sign height of 4.2 metres, as well as the shoulder against the guide edge shall be 0.5 metres.
