The procurement will be carried out by Innlandet county on behalf of a large number of counties, municipalities and intermunicipal companies. The objective of the procurement is to establish a joint system that shall streamline and modernise the procurement work in the participating organisations. The system shall contribute to better compliance of the regulations, reduced complexity, data driven work flow and a high degree of automation. The system shall have user friendly work processes and it shall support both contracting authorities and tenderers throughout the entire competition. The offered system shall be robust, secure and developed for cloud based operations, with the expectation of continual improvement, upgrades and further development in the contract period. The system shall support integrations with Doffin and TED, as well as be able to deliver correct and automated announcement forms. It shall also be possible to extract and share data via open APIs to support data driven development and connection to other systems. The framework agreement includes, as a minimum, KGV and KAV.
