The bidding process is conducted according to the Procurement Procedures for Projects Financed by CDB (January 2021), as published on CDB's website and is open to all bidders from eligible countries. Eligibility is extended to all countries. Bidders are advised to review the relevant eligibility criteria detailed in Section 4 and conflict of interest provisions in Section 5 of the Procurement Procedures for Projects Financed by CDB (January 2021), as published on CDB's website. Firms whether applying individually or in the form of a Joint Venture, shall: (a) be legally incorporated or otherwise organised in, and have their principal place of business in an Eligible Country; (b) be

more than fifty (50) percent beneficially owned by a citizen or citizens and/or a bona fide resident or residents of an Eligible Country, or by a body corporate or bodies meeting these requirements, as far as the ownership can be reasonably determined; and (c) shall have no arrangement and undertake not to make any arrangement whereby the majority of the financial benefits of the contract, i.e. more than fifty (50) percent of the value of the contract, will accrue or be paid to sub-contractors or sub-consultants that are not from an Eligible Country. Eligible bidders will be required to submit full qualification information with their bids establishing their eligibility to bid and qualification to perform the contract if the bid is accepted. Qualification requirements include, inter alia: 1. The Bidder shall submit audited financial statements for the last 3 years prior to bid submission deadline (2023 - 2025) or bank reference letters confirming financial standing for the stated period. 2. The Bidder shall demonstrate that it has successfully completed at least 2 contracts within the last 5 years prior to bid submission deadline, of comparable scale and complexity, including contracts of similar scope and magnitude. 3. Manufacturing experience and Technical Capacity (if the bidder is a Manufacturer): a. manufactured goods of similar nature and complexity for at least 3 years prior to the bid submission deadline. b. its annual production capacity of goods of similar nature and complexity for each of the last 3 years prior to the bid submission deadline, is at least two (2) times the quantities specified under the contract, as demonstrated by production records, capacity statements, audited or certified reports, or other documentary evidence acceptable to the Purchaser. 4. Manufacturing experience and Technical Capacity (Supplier): o (i), (ii), (iii) and the Bidder shall demonstrate that it has successfully completed at least 2 contracts of similar goods in the past 5 years, as demonstrated by copies of contracts or purchase orders, and certificates of satisfactory completion or client references.
