The procurement contributes to reducing emissions of HVAC's vehicles and machines, which reduces the impact on the environment in Oslo. There are minimum requirements for electrical and biogas in the requirement specifications and in the contract for transport (last mile): Tenderers are obliged to use vehicles that are either zero emission vehicles (i.e. 100% electric or hydrogen) or biogas vehicles that as a minimum fulfil Euro class 6/VI in the execution of the contract (last transport stretch/last mile). This requirement applies for the delivery of the goods and the service aspect service and repair contract in the contract. The requirements are set as a minimum requirement as this gives a stronger environmental effect than evaluating the environment as the award criteria. The environment will therefore not be included as the award criteria in this procurement.
