In this area we currently have approx. 60 persons who facilities risk analyses and approx. 75 people who follow up on risk and measures. If we count with all those who participate in risk analyses and carry out measures after risk analyses, the total number of affected will be approx. 500. We have an ambition in the long term to use the system for all risk management in Helse Midt-Norway. The system must therefore be adaptable to control all types of risk.
