Cur síos: Assessment of climate and environmental requirements. 3.1 Assessment of award criteria Based on the contract form with NS 3420 descriptions, conditions that affect the climate and environment will be an integrated part of the engineering design services and specified in the tender documentation, in order to reduce the total climate and environmental impact of the procurement. The contracting authority has assessed the possibility of affecting the project's climate and environmental impact as well as the suitability of the award criteria in DFØ's Criteria Wizard. Award criteria related to quality and environmental monitoring have also been considered in the construction phase, including offered resources, waste management and sorting, environmental monitoring, documentation and reporting. After an overall assessment, the contracting authority believes that concrete and binding climate and environmental requirements in the requirement specifications will give a better climate and environmental effect than the use of award criteria. The requirements ensure that all offered systems fulfil the stipulated environmental level and that the obligations can be followed up throughout the entire contract period. The contracting authority has therefore chosen to set climate and environmental requirements in the requirement specifications rather than emphasising these considerations as award criteria. 3.2 Climate and environmental requirements in the requirement specifications. The largest climate and environmental impacts in the project are related to material use, energy use in the operational phase and waste

management. In addition emissions from transport and construction site operation are assessed as relevant influence factors. Based on the assessments in chapter 3, concrete climate and environmental requirements have been prepared that are incorporated in the tender documentation and the requirement specifications. Krava is aimed at the conditions that have the greatest impact on the project's climate and environment footprint, and it ensures that the environmental ambition of the project is achieved in a predictable and verifiable way.
