2.1. Postupak

Naslov: Military Backpacks & Pouches

Opis: Danish Ministry of Defence Acquisition and Logistics Organisation (Hereafter "DALO") intends to enter into a Framework Agreement regarding military backpacks and pouches. The Framework Agreement is divided into 2 lots. Tenderers may choose to submit offers regarding either or both lots. With regards to Lot 1 (Military Backpacks): The Danish soldier and emergency personnel will use the backpacks for educational, tactical and operational tasks, both nationally and internationally. The Danish soldiers work in different environments regarding weather and climates, and the backpacks must be functional and durable throughout the change of weather. The backpacks will be used intensively for long periods of time, and will be carried physically by soldiers or loaded on vehicles. The backpacks must endure being dragged over uneven surfaces, being transported over water and get thrown with a heavy load from or onto vehicles. With regards to Lot 2 (Pouches): The Danish soldiers and emergency personnel use a variety of different pouches that have specific functions regarding the equipment and items they contain. The pouches will be mixed and matched depending on the task or mission. The soldiers and the emergency personnel will attach the pouches to their backpacks and the body armor for customization, for extra volume and easy accessibility. The variety of items that require a dedicated pouch varies from medical equipment, magazines for different types of firearms, grenades, tools, binoculars and more. The Danish soldier's works in different kinds of weather and climates, and each pouch must be functional and durable throughout the change of weather. The pouches will be used intensively for long periods, and will be transported by foot and on vehicles. While being attached to a backpack the pouches must endure being dragged over uneven surfaces, being transported over water and get thrown from or onto vehicles, containing a heavy load. DALO has prepared a prequalification questionnaire ("PQQ") which the candidates are encouraged to use when submitting their applications. The PQQ contains forms and templates for providing information etc. in accordance with the requirements in this Contract Notice. However, it is emphasised that it is the sole responsibility of the candidate that the information provided fulfils the requirements. The PQQ is available at the electronic procurement system. When submitting the offer (but not the request for participation /prequalification), the tenderer must submit a declaration stating that the tenderer (1) is not subject to any of the mandatory grounds for exclusion stated in Article 39(1) of the Defence and Security Directive and section 134 a of Act no. 1564 of 15 December 2015, as amended (the "Public Procurement Act"), and (2) to which degree the tenderer has unpaid overdue debt in relation to taxes or social security contributions under Danish law or under the law of the country in which the tenderer is established. A template for the declaration will be provided with the tender documents, which the tenderer may use. If the tenderer is composed of a group of entities (e.g. a consortium), including temporary joint ventures, a declaration must be submitted for each participating entity. Even if a candidate or a tenderer is subject to an exclusion ground, it will not be excluded if it has provided sufficient documentation that it is reliable. DALO will decide whether the documentation is sufficient. DALO's assessment will be made according to the guidelines in section 138(1)-(4) of the Danish Act no. 1564 of 15 December 2015, as amended (the "Public Procurement Act"). According to the Defence and Security Directive, a candidate may rely on the economic and financial standing and/or technical and/or professional capacity of other entities, regardless of the legal nature of the links with the entities. If a candidate intends to rely on other entities and wants the capacity of such other entities to be taken into account when DALO assesses the suitability of the candidate, the candidate must prove that the other entities will and are obliged to provide the relevant resources at the disposal of the candidate. DALO reserves the right to award lot 2 of the agreement (Pouches) based on the first indicative offer or any subsequent indicative offers.

Government Procurement Agreement or other trade agreements committing Denmark to open the public procurement market to tenderers established in that country. However, for reasons of overriding public interest, the contracting entity may refrain from excluding a candidate or tenderer that is subject to the ground for exclusion. No particular legal form is required. If the agreement is awarded to a group of suppliers (e.g. a consortium), the participants shall undertake joint and several liability and appoint one supplier to represent the group. It is pointed out that this procedure is subject to Article 5k of Regulation (EU) no. 833/2014, as amended. For the lot "Military Backpacks" The estimated value of the framework agreement is DKK 170.000.000,00, and the maximum value of the framework agreement is DKK 510.000.000,00. The reason for the difference between the stated values is the uncertainty regarding the final value of the framework agreement, see below. Hence, the estimated value constitutes DALO's most qualified estimate of the value of the framework agreement at the present moment, while the maximum value constitutes the maximum value of purchases under the framework agreement in its duration. For the lot "Pouches" The estimated value of the framework agreement is DKK 80.000.000,00, and the maximum value of the framework agreement is DKK 240.000.000,00. The reason for the difference between the stated values is the uncertainty regarding the final value of the framework agreement, see below. Hence, the estimated value constitutes DALO's most qualified estimate of the value of the framework agreement at the present moment, while the maximum value constitutes the maximum value of purchases under the framework agreement

in its duration. The uncertainty regarding the final value of the framework agreement is primarily caused by uncertainty regarding the operational needs of the Danish Defence through the duration of the framework agreement, including in particular uncertainty about specific deployments and mission areas, which is not possible to foresee for the entire span of the framework agreement. Thus, changes to the operational needs of the Danish Defence compared to the existing situation and needs may cause a significantly larger expenditure under the framework agreement than what is expected at the moment. The request to participate and the offer shall be in the language stated in this notice. Regarding "Selection criteria" it is specified that DALO will select 5 candidates for each lot by applying the criteria stated herein, unless DALO receives less than 5 compliant requests for participation. Please be aware that it is stated in the notice that "The procedure will take place in successive stages. In each stage, some participants may be eliminated." The framework agreement is divided into 2 lots. Tenderers may choose to submit offers regarding either or both lots. Lot 1: The Agreement concerns multiple backpacks with different special military functions, hereunder: - Small 30-40L Backpack (Daypack) - A 65-75L Backpack - A 120-150L Backpack - Sidepockets to fit on Backpacks - Heavy load carrier - Combat Medical Backpack - Medic Daypack The Danish soldier and emergency personnel will use the backpacks for educational, tactical and operational tasks, both nationally and internationally. The backpacks must have adjustable harnesses to ensure an ergonomically fit to the individual soldier's anatomy with a short or long back, broad or narrow shoulder. The harness includes adjustment options on the back piece, shoulder straps, breast strap and hip belt. The backpacks and sidepockets must be comfortable to carry while standing, walking, running and laying on the ground in shooting position. The Danish soldiers work in different environments regarding weather and climates, and the backpacks must be functional and durable throughout the change of weather. The backpacks will be used intensively for long periods of time, and will be carried physically by soldiers or loaded on vehicles. The backpacks must endure being dragged over uneven surfaces, being transported over water and get thrown with a heavy load from or onto vehicles. The standard backpack, the heavy load carrier and the medical backpack may be worn while the soldier is wearing the body armour system PICO MV /Brokosbelt supplied by TYR Tactical, US. The backpacks and the PICO MV/Brokosbelt shall be compatible. All backpacks must have MODular Lightweight Load-Carrying Equipment (MOLLE) system to make it customisable with other pouches and attachable side pockets. The products are in most cases required to fulfill very specific military requirements, e.g. Multicam (R) pattern, NIR coating to hide the light signature of the products and special camouflage patterns as further described in the Agreement. The Agreement shall ensure DALO's supply of backpacks for a period of 7 years from the commencement of the Agreement. The Agreement entails the following obligations which shall be the Supplier's responsibility to achieve: 1) After Commencement of the Agreement, the Supplier shall fulfill a list of pre-conditions as part of an implementation period. The pre-conditions requires the Supplier to submit design documentation of products part of the Agreement. In addition, the implementation period requires that the Supplier shall submit 3 samples of all products included in the tender, for DALO's quality assurance. The implementation period is limited to 9 months from Commencement of the Agreement, but may be shortened if the pre-conditions can be achieved faster. Failure to fulfill the pre-conditions within 9 months will give DALO the right to terminate the Agreement. 2) Design and production of custom backpacks, tailored to meet special demands that DALO has for the final products, 3) Minor design changes to the offered products upon DALO's request 4) Training in the correct use of the products offered, 5) An integration design between the offered backpacks, and DALO's existing BROKOS belt (Combat MOLLE belt) to allow for weight transfer between the two products. 6) During the Agreement, the Supplier will be required to be able to change the camouflage pattern from the offered pattern to DALO's own pattern.

If the candidate relies on the economic and financial standing of another entity or other entities (e.g. a parent or sister company or a subcontractor), the information must also be provided for each such entity or entities.

The references shall only be military backpacks when applying for Lot 1, and Pouches for military use when applying for Lot 2. 2) The design work carried out with regards to the delivery - It is considered positive, if the reference contains products that have been designed to meet customer needs. The degree and volume of design and customization is regarded as especially positive, and should be described in as much detail as possible, 3) The date of the delivery – It is considered positive, the more recent the reference is, 4) The size of the delivery - It is considered positive, the bigger the size/quantity/volume of the submitted reference is, 5) The recipient of the delivery - It is considered positive, if the reference concerns deliveries to militaries within NATO countries or NATO allied countries. "Similar delivery" means a delivery which contains as many identical aspects in regards to the above list of characteristics and section "Object" of the notice.
