### **VII.2.2. Razlozi izmjene**

Potreba za izmjenom nastala zbog okolnosti koje pažljivi javni naručitelj nije mogao predvidjeti (čl. 43. st. 1. t. (c) Direktive 2014/23/EU, čl. 72. st. 1. t. (c) Direktive 2014/24/EU, čl. 89. st. 1. t. (c) Direktive 2014/25/EU)

Opis okolnosti zbog kojih je izmjena nužna i objašnjenje nepredviđene naravi tih okolnosti:

Contract Value: This contract has been affected by additional work requirements subsequent to its commencement in 2016 that could not have been foreseen, including funding for LED retrofitting, public realm works and enhancing streets and sites within council areas. Contract Value increased from £9,000,000 to £14,400,000. Contract Duration: The contract period has been extended, it was extended initially by 6 months beyond the contract term due to Covid-19 workload restriction. A further 6 months extension has been given as the Covid-19 pandemic continues to have an impact on the ability of Dfl to develop tender competitions and the roads construction industry to respond to tender opportunities.
