The contract also includes the establishment of a temporary roundabout in Skumsrudvegen, establishment of site roads, excavation on land, work on cultivated land such as laying of water and sewage pipelines, reinventing matter and separation of rock from masses, drilling under Skumsrudvegen, pipe sheet for water and sewage routes skumsrudvegen-VBA, reception and laying of PE pipes and pipe parts, refill works, adjustments etc. Hammer drilling shall be carried out for 3 DN813, 1 DN457 pipe pipe under Skumsrudvegen, and pulling in water and sewage pipelines for a pipe under Skumsrudvegen.
