The current sub-contracts for transport and reception of hazardous waste expire 31.12.2026. In order for the agency to offer Oslo municipality's inhabitants the services for the receipt and collection of hazardous waste, it is necessary that the agency has contracts that ensure that the hazardous waste is transported to certified reception for further treatment and destruction. The current estimates are uncertain, i.a. due to new possible fractions and how the existing fractions develop.
