Of these, large ciber species are prioritised (park liquer, giant lick and cross) and giant sprinkler seed bodies along waterways. The contract could also be used for controlling other individual instances of foreign plants or several foreign plant species within individual areas or stretches (e.g. within protected areas, along defined stretches of road etc.). The contract is a single procurement with a duration of two years, with options that can be taken up for 1+1 year.
