Sub-tender B: Systems for insight, service building and communication (publication, dialogue/participation, analysis, data distribution, etc.), delivered and operated as a cloud service. The contracting authority is free to choose several tenderers to fulfil the need. The contract's total value for four years operation is estimated to NOK 7,000,000.
