The scanner shall be installed at the PET centre at St. Olavs Hospital. The expected delivery of PET/CT will be: Q2/Q3, 2027. Offered equipment shall cover PET/CT examinations (oncology, neurology, cardiology, inflammation), simple diagnostic CT examinations, as well as planning doses for radiotherapy. The scanner shall endure heavy loads and it shall be usable with different isotopes. It shall deliver PET/CT pictures of high quality and with good diagnostic precision. At the same time 1 option shall be offered for an equivalent PET/CT scanner to St. Olavs Hospital, as well as 3 options on an equivalent PET/CT scanner to Helse Sør-Øst.
