Pagrindiniai procedūros ypatumai: The assignment consists of planning and realising construction work for the project by carrying out a collaboration phase ("phase1") with the preliminary project and thereafter carrying out detailed engineering design services and construction (hereafter called the "execution phase" or "phase 2"). The work's expected extent at the time of the competition notice is described in annex A1 General part. A preliminary project shall be prepared in accordance with the frameworks and prerequisites set by the contracting authority and which are highlighted in the contracting authority's expectation for a preliminary project report (see the A2 Framework for interaction). The preliminary project will be carried out in collaboration with the early involvement of the general contractor and supplier of prefabricated theatres. The overall objective with the interaction phase is to jointly develop the best possible decision basis for the start-up of development within the framework that have been decided for the project, including identifying the correct price.
