Pagrindiniai procedūros ypatumai: Stable operation of the network infrastructure will depend on the products that are connected to the municipality's network being compatible with each other. See the detailed description in SSA-K Annex 3 the Contracting Authority's Technical Platform. The need for the procurement of network equipment will typically occur when the existing equipment achieves end-of-life, when there are expansions, changes in the existing network, new establishment or moving departments. The call-off of consultancy services will occur in connection with the above points.
