Pagrindimas: The subject matter of this procurement concerns the delivery of a Trusted Certificate Service (TCS), including the provision of publicly trusted digital certificates, Public Key Infrastructure (PKI) services, and associated technical and operational support to GÉANT and its member organisations. The services procured under this tender are primarily system-level, infrastructure, and back-end services, delivered to National Research and Education Networks (NRENs) and their affiliated organisations, rather than directly to end-users. While certain components of the service (such as management interfaces or portals) may include user-facing elements, these are intended for professional users operating within organisational contexts, and are not designed as public-facing services or products intended for general consumer use. As a result, the inclusion of specific accessibility requirements for persons with disabilities, as referred to in Article 42 of Directive 2014/24/EU, is not considered applicable or proportionate to the subject matter of this procurement. Notwithstanding the above, GÉANT expects the contractor to adhere to generally accepted industry standards and best practices, including where applicable considerations relating to usability and accessibility within professional environments.
