Aprašymas: The Contracting Authority hereby invites tenderers to a competition for a contract for purchase of company health services. The contracting authority shall enter into a contract for 2 years, with an option for an extension for 2+2 years with one tenderer. A comprehensive description of the delivery is in the annexes to the tender documentation.

Pirkimo būdas: Atviras

Pagrindiniai procedūros ypatumai: The contracting authority shall enter into a contract for 2 years, with an option for an extension for 2+2 years with a tenderer for the procurement of company health services. The value of the procurement is estimated to be NOK 1,700,000 - NOK 3,000,000 excluding VAT per annum. The annual extent is uncertain, as the municipality has not procured company health services in the past and some internal assignments shall be taken care of. The estimated value shall be seen as a guideline and is not binding for the contracting authority. The volume can vary both up and down and the contract period will depend on, among other things, the contracting authority's needs, activities, budgetary situations and other framework factors. A contract shall be established with one tenderer for the procurement of company health services for the municipality's service locations. The agreement shall facilitate a safe working environment that promotes good work health for employees and it shall ensure that the statutory obligations in the Working Environment Act and associated regulations are safeguarded. Contract start: 01.01.2027. Options: 1. Extension of the contract for 2+2 years 2. Occupational vaccines 3. The Contracting Authority reserves the right to cancel the competition if the submitted tender offer is higher than the budgeted or awarded funds. The length can be set longer as this is not a framework agreement

If a tenderer has a justifiable reason for not submitting the documentation required by the contracting authority, he can document his economic and financial capacity by presenting any other document that the Contracting Authority deems appropriate.

Documented by a description of the tenderer's up to 3 most relevant assignments in the course of the last 3 years. The description must include a statement of the contract's value, date and recipient (name, telephone number and e-mail address). It is the tenderer's responsibility to document relevance through the description. Tenderers can document their experience by referring to competence of the personnel he has at his disposal and can use this assignment, even if the experience has been worked up while the personnel have served another service provider.
