Tenders can be submitted for parts of the assignment; Sub-contract 1: Various wearing steel. Sub-contract 2: Küper Combi or equivalent. Tenderers are invited to submit tenders for one or both lots. There are no limitations on how many sub-contracts one tenderer can be awarded; a tenderer can, therefore, be awarded both sub-contracts.
