Pagrindiniai procedūros ypatumai: Operation and maintenance includes, among other things, operational visits, reporting and condition assessments. The portfolio consists of different manufacturer and type of lifts. The contract will apply for the lifts stated in the lift overview for the areas covered by the framework agreement. Facilities can be added to or taken out of the contract during the contract period. New installations that come into the contract shall have the same terms and will be priced alike with equivalent lift facilities that are already priced in the contract. Lift installations that are in the guarantee period will only come when the guarantee has expired.
