The facility will be used for conducting Over-The-Air (OTA) antenna measurements, supporting advanced research and experimental validation in wireless communications. The chamber will enable research on current and future wireless systems and will further strengthen the existing high-level research in the field. The object of the tender process is described in more detail in the invitation to tender documents. A dedicated space has been allocated for both the chamber and an adjacent control room. Detailed layouts and spatial specifications are provided in the appendices to this tender. In addition, a separate appendix outlines the existing measurement equipment that will be installed and utilized within the new chamber. The chamber will be constructed within the Sähkötalo building, in the F-wing. The chamber is effectively located at the ground-floor level, allowing convenient access through large doors. This facilitates the transportation and installation of sizeable chamber components and measurement equipment. The selected supplier will be required to conduct a site survey promptly after contract signing. The purpose of the survey is to verify all relevant dimensions, environmental conditions, and technical details necessary for the design and installation of the chamber.
