Pagrindiniai procedūros ypatumai: The aim of the procurement is to enter into a framework agreement for company health services such as: • Fulfills the requirements in the Working Environment Act § 3-3 and accompanying regulations, including regulations on organisation, management and participation chapter 13 and the regulations on administrative schemes chapter 2 • Ensures the municipalities expertly, preventive and risk based assistance in the systematic HSE work Agreement shall cover all employees in Skaun municipality, Melhus

municipality and Midtre-Gauldal municipality, which, according to law and regulations, shall be included in company health services. The contract can also be used by Kapto, Vekst Melhus and Runa Vekst, which are the municipalities' growth companies, the framework agreement applies for 3 years, from 01.02.2027 – 31.01.2030, with an option for an extension for up to 1+1 year. The total maximum agreement period is 5 years.
