Pavadinimas: Framework agreements independent inspections

Aprašymas: Forsvarsbygg invites tenderers to submit tenders for framework agreements for independent inspections. The contracting authority aims at entering into identical framework agreements with up to five tenderers, provided that a sufficient number of suitable tenders are received. Tenderers will be ranked in connection with the competition based on the award criteria, see the tender documentation part I for further information.

Pagrindiniai procedūros ypatumai: The framework agreement shall cover all inspection areas that are at all times in accordant with the current law and regulations and any decisions of municipal authorities. Each call-off will give a description of the need in the concrete assignment. The control assignments are pursued in the Planning and Building Act's chapter 24 and further described in the building application regulations (SAK10). The inspection includes both engineering design services and execution, and the control assignments apply to the following areas: Development class 1: 1. Humidity protection for application obliged wet rooms in residences 2. Air tightness in new residences Development classes 2 and 3: 3. Building physics 4. Structural security 5. Geotechniques 6. Fire safety
